We are seeking two qualified individuals to join the newly added Commercial Vehicle Inspection program within the Traffic Unit of the New Westminster Police Department. The role of a Commercial Vehicle Inspector, which has a Special Constable appointment, is inspection and enforcement work of considerable responsibility involving the enforcement of municipal bylaws and provincial statutes. The Commercial Vehicle Inspector will work both independently and jointly with Police Constables in the Traffic Unit for the purpose of improving the safe operation and mechanical fitness of commercial vehicle traffic for the City of New Westminster.

REQUIREMENTS:

- Completion of high school graduation, plus the successful completion and maintenance of the Commercial Vehicle Safety Alliance certificate, plus Sound related experience. An equivalent combination of related education and experience acceptable to the employer may be considered.
- Successful completion of the Emergency Vehicle Driving course.
- Valid Class 5 BC driver's license with Air Brake Endorsement.
- Considerable working knowledge of related laws and which include but not limited to the New Westminster Municipal Bylaws; Motor Vehicle Act and Regulations; Commercial Transport Act and Regulations; Passenger Transportation Act and Regulations.
- Ability to deal with the public courteously, firmly and tactfully in a variety of situations and problems utilizing effective conflict resolution skills.
- · Ability to write and speak effectively, prepare reports and records and give evidence in Court.
- Sound knowledge of modern enforcement methods and techniques.
- Some mechanical ability and knowledge.
- Sound knowledge of City geography.
- Ability to analyze situations objectively and take fast, effective course of action without immediate reference to higher authority.
- Ability to operate a variety of technical police related equipment.
- Ability to work outside in all weather conditions.
- Knowledge of first-aid principles and applications.
- Physical ability for the work (i.e. standing for long periods, crawling under vehicles for purposes of conducting mechanical safety inspections). Note: A physical abilities assessment will be administered.
- Ability to pass and maintain a comprehensive Police background check which includes a polygraph examination.
- Eligibility for the appointment to Special Constable.
- Ability to work a compressed work week consisting of days and afternoons scheduled between Monday to Saturday.
